I. MEDICAL WOMEN'S INTERNATIONAL ASSOCIATION

1. PRESIDENT'S MESSAGE

Professor Dr. Dr. Bettina Pfeleiderer, Germany

This has been a very productive summer for our MWIA committees and the MWIA executive!

Before I go into more detail, I want to thank all of you who had completed the **MWIA membership survey**: we recorded an amazing high number of **1150 responses** and I presented some of the data related to the Western Pacific region (n = 227) at the MWIA Western Pacific Regional meeting in Hong Kong 25-27th August 2017.

After analyzing the responses of our survey it became evident that MWIA needs to sharpen its objectives, since no clear response pattern emerged from the question what MWIA is standing for. Based on this feedback I revised the objectives/visions for MWIA, which was approved by the MWIA executive as follows:

MWIA is as an international non-governmental organization (NGO) of Medical Women and medical students from many different countries and cultures.

- We have an important voice on all issues of interest to medical women e.g. work-life balance, maternity leave, career progression, fighting discrimination, mentoring of young medical doctors and students
- We initiate and support scientific projects relating to health and well-being – locally, nationally and on a global scale
- We have developed training modules for physicians e.g. on gender mainstreaming, violence against women and girls, adolescent sexuality
- We serve as a platform for medical women and students to foster dialogue and action on various health issues internationally e.g. female genital mutilation, women's reproductive health, maternal and infant mortality

Further analyses of our questionnaire revealed that members wanted MWIA to address mainly topics such as mentoring and leadership, work-life balance, violence against women and children, as well as sexual harassment at the work place. Also many of you reported that they had experienced or experience some form of sexual harassment. The MWIA scientific committee has taken this up and a **sexual harassment questionnaire** was developed by Prof. Jan Coles from Australia, Co-Chair of the scientific committee, in close collaboration with Dr. Antonella Vezzani (chair of the scientific committee), Dr. Yvonne Buowari, and the MWIA president.

The data obtained will provide MWIA and its members with descriptive data that can be used to sensitize the medical community to sexual harassment to reduce this form of violence. Also supportive measures of women doctors who experience sexual harassment will be suggested based on responses of the survey.

You should have all received the link to **our sexual harassment survey** meanwhile and I invite you all to take part in this survey to support this important project.

I also had the pleasure to attend the MWIA Western Pacific Regional Conference in Hong Kong - 25-27th August. Regional meetings are the pillar of MWIA's regional networking and I want to congratulate Dr. Cissy Yu and the Hong Kong Women Doctors' Association, the Hong Kong Academy of Medicine, and the Midwives Association for this inspiring and well-organized congress. Over 200 participants from Western Pacific countries and regions, UK, Germany, USA, Turkey and Nigeria attended (see the group picture).



I had the honor to present a keynote with the title: "Medical Women and Women's Health - A Global Perspective" and concluded my talk by saying that even steps that seem small in comparison can result in bold action and will have a sustainable positive impact on women's health. **We as medical women should not stop raising our voice as medical doctors nationally and globally on important health related topics!** MWIA is an important global partner in this endeavor!

Last but not least, the MWIA scientific centennial subcommittee started to work, which is co-chaired by the MWIA president and Prof. Theresa Rohr-Kirchgraber; the committee consists of MWIA members from all MWIA region, as well as AMWA members. The overarching theme of the congress is "*The Centennial Congress of the Medical Women's International Association: Medical Women- Ambassadors of Change in a Challenging Global World.*" We completed our list of subtopics and themes for abstracts and drafted an abstracted submission form. As soon as the centennial congress webpage is online you will find the abstract submission information. Also, the congress venue in New York has been booked and the contract signed last week. The final date for our MWIA congress is the **25-28th of July 2018** now. Please mark this in your calendar.

I am looking forward to my visit to India in the middle of December attending the National Conference of Association of Medical Women in India (Mumbai Branch).

5. NEWS FROM AROUND THE REGIONS

Brazil

Of the 82 members of the Medical Association of Sao Paulo, 8 are women and all are members of the Brazilian Medical Women's Association (ABMM).

In July, there was a very successful presentation at the ABMM- Parana section about "Exercise and Women's Health."

Dr Marilene Melo, ABMM vice president, went to a meeting of Women Medical Students and spoke about Gender Specific Medicine and the aim of including this important subject in medical school curriculum.

The new executive for ABMM-SP for 2018 was approved. The president will be Prof Magda M C Sampaio, Professor of Pediatrics at the University of São Paulo Medical School.

There was a meeting of GAMT (a support group for women with Turner's Syndrome), which is the object of an important study by Prof Ieda Verreschi, of ABMM executive and a Professor of Endocrinology at EPM (Paulista Medical School).

Dra Fátima Alves, ABMM President's doctorate thesis: "A clinical data and hearing of individuals with Alport syndrome" was cited in an important international article about the subject. She also presented in August during the Brazilian Congress of Otorhinolaryngology a lecture about vaccination and Otorhinolaryngology: "New options of vaccines with impact in Otorhinolaryngology."

Dr Sonia Rolim will be the new representative of ABMM at the MWIA violence module. She is a professor of Gynecology at the Santa Casa Medical School, and a member of many national and international associations, and Director of ABMM. She is a member of the Center of Accidents and Violence at Santa Casa Medical School, representing the department of Gynecology.

Canada

The annual conference of FMWC was held from September 15-17 in Ottawa. The theme of the Conference was Women's Health and Well-Being: Connected, Compassionate and Courageous. There were 170 in attendance. As part of the meeting, there was a march on Parliament Hill to protest against the proposed Liberal tax reform on private corporations. Check out this you tube

Due to ongoing lobbying by the Federation, British Columbia has become the latest province to provide the human papillomavirus (HPV) vaccination to boys, as part of B.C.'s publicly funded immunization program.

In addition to the new HPV Awareness week, October 16-20, 2017, is the annual cervical cancer awareness week when clinics are encouraged to sign up to hold a Pap test clinic.

Hong Kong

The VP for the Western Pacific, Dr. Cissy Yu, is from Hong Kong. She will be attending the WHO Regional Committee for the Western Pacific from 9-13 October 2017 in Brisbane, Australia, the AGM and Strategic Planning Workshop of Australian Federation of Medical Women (AFMW) from 11-12 November 2017 in Sydney, Australia, and will be joining Dr Deb Colville, National Coordinator of AFMW, to meet individual MWIA members in New Zealand in November 2017.

Nigeria

Dr Stella Kokoricha Essiet, the newly elected National Coordinator for the Medical Women's Association in Nigeria, writes that the biennial Conference and 40th Anniversary celebration of MWAN was held in Abuja from September 17-19, 2017. The theme of the conference was "Women and children in humanitarian crises."

The conference was preceded by a Road Walk led by the wife of the Executive Governor of Kebbi State, Dr Zainab Shinkafi Bagudu, around the major areas of the city on September 14th.

Dr Zainab S. Bagudu and another medical woman, who is also the wife to a state Governor, led the Association in a medical outreach to a community in a suburb of Abuja called Piwoyi, where hundreds of people were treated to free consultations, free drugs and some refreshments on Saturday the 16th.

About four hundred and four member delegates from 30 MWAN states branches were treated to a rousing welcome party at the National Hospital Foyer on September 17th. The opening ceremony took place at the Sheraton Hotels and Towers with many relevant stakeholders including the wife of the vice president, the Minister for Health Prof. Isaac Adewole, and Dr Ehanire, chairman of the Senate Committee on health, Dr Olarenwaju Tejuosho, a representative of the UN to Nigeria, Dr Alakija, who gave the key note address and so many others. Members were treated to a Social night by a MWAN elder and past National Coordinator, Dr Funke Lawson. The scientific sessions were very rich with so many good presenters and delegates were awarded ten CME points at the end of the two scientific sessions held.

The General Assembly took place at The Merit House on September 19th, where issues of the Association and welfare of members were deliberated upon extensively. Dr. Yvonne Dabota Buowari spoke on behalf of the MWIA Scientific Committee about the new Sexual Harrassment Survey, which is now open for completion. The election took place for the new executive to pilot the affairs of the Association for the next two years. Their inauguration took place that same night at the sumptuous investiture dinner of the new MWAN President, Dr. Joyce Barber, at Sheraton Hotels with so much excitement. Many deserving members got awards from the outgoing president and it is worthy of note that the new president was awarded the Irene Ighodalo's pin. The transition was a very smooth one. There was so much dancing and merry making till the wee hours of the morning of September 20th when the final goodbyes were said. It was indeed a memorable time for all of us.

United States

July: AMWA partnered with Green Science Policy to offer online webinars on six classes of chemicals of concern to educate physicians.

August: AMWA board members, MWIA NGO representatives to UN were working on finalizing the venue and details of the upcoming MWIA Centennial Congress to be held in NYC in 2019.

September: AMWA hosted a webinar: “On how to position yourself as a physician leader” which was well received by the membership. The AMWA interim meeting was held on Sept 15-17 in Kansas City and there was a special event honouring women physicians in World War 1. The meeting was well attended by physicians, medical students and residents. AMWA is a co-sponsor of the 8th Biennial National Conference on Health and Domestic violence in San Francisco. AMWA is also a co-sponsor of the Gender Divide in Health Care Professions (2nd Annual women in science and health care symposium) at the Rosalind Franklin School of Medicine in Chicago.

6. WESTERN PACIFIC REGIONAL MEETING OF MWIA

The 2017 WP Regional meeting was hosted by the Hong Kong Women Doctors Association. 247 delegates, from 13 countries, speaking over 20 languages attended. These included Germany, Turkey, United States, United Kingdom, People’s Republic of China, and Nigeria, as well as the member countries of Western Pacific Region, being Australia, New Zealand (individual member), Japan, South Korea, Taiwan, Philippines, and of course Hong Kong.

A business meeting was held on the first day addressing reports from the member country’s associations, and an individual member Dr Margaret Maxwell from New Zealand (former VP of WP MWIA). Dr Bettina Pfeleiderer International President, and Dr Cissy Yu, VP for WP MWIA addressed the meeting. They discussed the current activities and policies of MWIA. Three resolutions were drafted and will be submitted to MWIA. The Australian Federation of Medical Women (AFMW) will nominate the incoming Vice President of MWIA (Western Pacific Region) and the result will be announced by December 2017. Korea Medical Women Association (KMWA) will be organizing the next Regional Conference; Philippines Medical Women Association (PMWA) will be hosting the next Regional Business Meeting in Cebu to discuss the governance and collaborations among the various national associations in the region.

The conference themes were Women Health and Empowerment.

The scientific meeting was held on the second day with two plenary sessions and two concurrent sessions. The two parallel themes of the MWIA meeting Women’s Health and Gender Equity, and the Professional Lives of Medical women were addressed in these sessions. The concurrent sessions had “Sunrise” and “Sunset” themes, one addressing issues in Maternal Child and Adolescent health, the other addressing later- life topics, menopause aging and palliative care.

The meeting had a very positive mood. It was a great meeting of minds, friendly and very well organized. If there was a negative it was the typhoons, which meant that our female doctors from Macau were serving their communities and unable to join us. The second typhoon also

unfortunately caused the cancellation of hospital visits on the Sunday, much to the disappointment of those who otherwise have enjoyed these opportunities.

7. REPORT FROM MWIA'S REPRESENTATIVES TO THE UN

Report of activities from July to September, 2017

Drs. Keswani and Murthy and youth Representative, Aishu Narasimhadevara, have been representing MWIA by attending events held in and around the United Nations.

July: Aishu Narasimhadevara attended the HLPF- High Level Political Forum and represented MWIA and interacted with several youth delegates. Aishu Narasimhadevara has been reappointed to the DPI NGO Youth steering committee for 2017- 2018. Mini Murthy attended a reception on behalf of MWIA at the Taipei Educational and Cultural Office, hosted by the Ambassador during the High Level Political Forum (HLPF).

August: Mini Murthy was invited to moderate a health panel at the annual UNDPI NGO Conference – Intergenerational Dialogues and the youth rep of MWIA was an attendee at the conference. In August, 2017, Murthy also represented MWIA at the executive meeting of DPINGO as a newly elected member and discussed potential opportunities of working with other health NGOs in advancing SDG 3. Mini Murthy attended and presented at the Western Pacific Regional Conference of MWIA in Hong Kong.

September: Mini Murthy attended the monthly executive committee meeting and planning committee meeting for CSW 2018. Aishu Narasimhadevara and Mini Murthy represented MWIA by attending the general debate and several events on health, gender equality and advocacy during the 72nd UN General Assembly. In the late summer and fall each year, the various WHO Regions hold their annual regional committee meetings. Due to MWIA's official status with WHO, it is invited to send a representative to each of the meetings

8. REPORT FROM WHO Regional Committee Meeting for SE Asia

In the late summer and fall each year, the various WHO Regions hold their annual regional committee meetings. Due to MWIA's official status with WHO, it is invited to send a representative to each of the meetings.

I had the pleasure of attending the WHO Regional Committee meeting for South East Asia on behalf of MWIA from September 6-10, 2017, in the Maldives.

There are 11 member countries in the region. The Director is Poonam Ketrapal Singh. There was a great deal of business on the agenda covering a variety of health related topics. As an example, the region boasts many achievements by its various members such as eliminating

neonatal tetanus, decreasing maternal mortality by 69% and under 5 mortality by 64% in Sri Lanka, Thailand and the Maldives, and eliminating lymphatic filariasis in Thailand. Thailand became the first country in Asia and the second globally to eliminate mother to child transmission of HIV and Syphilis.

The countries of the region signed the Male Declaration in Building Health Systems Resilience to Climate Change.

It was a great opportunity to network on behalf of MWIA and to see the workings of WHO in the region where the national associations can be actively involved.

In early September, the Executive Committee met in Brussels, coinciding with the start of the third edition of AGORA, EWL's feminist summer school.

The agenda for our Executive Committee meeting on 7 September was packed. We spent time discussing **EWL's funding policy**, including topics like ethical funding, reviewed our **various Working Structures, EWL membership** and how to implement the **members' engagement strategy**, adopted during the 2017 General Assembly.

A key date in our schedule for 2017 is the [EU Annual Colloquium on Fundamental Rights](#) taking place on 20-21 November, which as you know is focusing on "women's rights in turbulent

times". We are in contact with European Commission Vice President Timmermans Office to discuss how EWL can best participate and contribute.

The next day, we spent the morning with the 50 **AGORA** participants, talking about EWL and working in small groups exchanging information and ideas on a number of topics, from cyber violence to intergenerational feminist leadership, campaigning and creating a diverse and inclusive feminist movement. It was great to meet these amazing young feminists from all over Europe and hear from them how we can work together to build a true feminist Europe.

3. **WONCA extends** an invitation to colleagues to join them at the innovative *1st International Perinatal TOTAL Health Congress*, in Sinaia, ROMANIA, from 27th to 30th June 2018. This will look at the first one thousand days of life, and the theme is proving popular with family doctors globally. 4. **The World Medical Association** made a plea to all member states at the UN General Assembly to sign the Treaty on the Prohibition of Nuclear Weapons. The WMA, together with International Physicians for the Prevention of Nuclear War, the International Council of Nurses

and the World Federation of Public Health Associations, has signed a joint statement welcoming the landmark treaty as ‘a significant forward step towards eliminating the most destructive weapons ever created, and the existential threat nuclear war poses to humanity and to the survival of all life on Earth.’

5. **Chile**’s Constitutional Tribunal voted to legalize abortion under three circumstances. With this shift, Chile will no longer be considered one of the most restrictive countries in the world in terms of abortion laws.

6. Women Deliver’s **Deliver for Good** is a global campaign that applies a gender lens to the Sustainable Development Goals and promotes 12 critical investments in girls and women to power progress for all. <http://womendeliver.org/deliver-for-good/>

7. **High Impact Practices** are evidence based family planning practices. A new website has been launched. <https://www.fphighimpactpractices.org/>

8. **Society of Obstetricians and Gynecologists of Canada** wrote to Health Canada voicing their concern about the recent approval of a generic "Diclectin" (doxylamine-pyridoxine), which contains the artificial sweetener, mannitol, for the treatment of nausea in pregnancy. Mannitol is contra-indicated for pregnancy by the FDA.

They also released a ground-breaking **clinical practice guideline** to raise awareness among health care professionals on how to screen for and manage substance during pregnancy. Even though the health risks to the fetus are well known, at least 11% of Canadian women report smoking or drinking alcohol during pregnancy, and another 1-2% admit to using opioids and cannabis.

9. **FP2020** held its **Family Planning Summit** in London, UK, to discuss efforts to reach the Family Planning 2020 (FP2020) goals and ensure that more women and girls around the world are able to determine if and when they have children. Family planning is a best-buy in global development. When women and girls have access to family planning, they are able to complete their education, create or seize better economic opportunities, and fulfill their full potential—in short, entire families, communities, and nations benefit. In addition, eleven **‘global goods’** covering six themes were highlighted at the Summit. These global goods are a diverse set of initiatives of vital importance to the reproductive health sector, involving combinations of governments, donors, organizations, and multilateral agencies:
