The title of my message was 'From whispers to amplified voices'. It was a time to hear from the MWIA amazons who were in Beijing 25 years ago and these included Past Presidents Dr Florence Manguyu, Dr Shelley Ross, UN Representative Dr Satty Keswani and Dr Christine Sadia, current regional VP for the Near East and Africa region. Each of the MWIA Regional VPs i.e. Dr Edith Schratzberger-Vecsei, Dr Elizabeth Lichtenstein, Dr Madakini Megh, Dr Magda Sales Carneiro, Dr Desiree Yap, Dr Vivien Brown made presentations on how things had progressed in their different regions in the past 25 years. Prof Dr Dr Bettina Pfleiderer, Past President, Dr Helen Goodyear, Treasurer, and chair of yMWIA Dr Genevieve Koolhaas also provided interesting perspectives.



On the 12 th September, it was a great honour and privilege for me to be invited by the China Medical Women's Association (CMWA) to join in the 2020 virtual annual

congress, and to celebrate the 25th anniversary of CMWA. 'The role of medical women in addressing the intersections pandemics of COVID-19 and violence against women and girls".

It was my pleasure to give a Goodwill message on the 19th of September at the MWIA Near East and Africa Regional Congress pre-conference webinar on 'Gender and COVID- 19' in place of the

6. Message from MWIA Past President

Prof. Dr. Bettina Pfleiderer- Germany



Since writing my last message, the COVID-19 pandemic still controls our lives and activities. Again – in my role as MWIA past president and/or MWIA representative, I have been attending many virtual meetings on behalf of MWIA in the last three months. I will just highlight a few.

I had the honor to give some remarks at the MWIA event "Women Doctors Around the World: Advocates for Women's Empowerment" to commemorate the 25th Anniversary of Beijing Declaration and Platform for Action (BPfA) on the 22nd of August. The event was put together by MWIA's Secretary General Prof. Dr. Padmini Murthy with an impressive set of speakers. Dr. Murthy also moderated the event. For me, it was very inspiring to listen to the history and regional reports presented in this meeting and the role MWIA played and is still playing!

Indeed - some progress had been made since the Beijing Declaration and Platform for Action was put in place 25 years ago. However, there is still unfinished business and it is time to turn vision into sustainable action. We are still waiting for a full implementation of the BPfA and to continue to make sure that women and girls are not left behind globally.

Female physicians need to be role models as important stakeholders in accelerating the pace of change:

- Female Physicians are an important first line responder group and advocates to prevent and combat all forms of gendered violence against women and girls.
- ➤ We need better working conditions and to tackle the gender pay gap for female physicians, as well for all women globally and female physicians should raise their voice in tackling this injustice.
- ➤ Gender equity and gender aspects related to COVID-19 but also to other diseases should be included in all level of medicine and gender sensitive medicine needs to be taught already at medical school to improve medical treatment for all.

A global network such as MWIA is vital to spearhead those discussions and stimulate actions of our members to serve as ambassador of change and pf women's human rights now and in the next 25 years.

MWIA is also a European-wide member of the **European women's lobby** (**EWL**) and **I am MWIA's current representative to the EWL**. I was in this role attending the EWL board meeting virtually at the afternoon of the 7th of September and the EWL General Assembly (GA) at the afternoon of the 8th September in the afternoon (see the photo to the right).



Over 100 EWL members from across Europe and EWL staff took part. Many ideas were exchanged to turn EWL's goals into real actions. Among many topics, EWL's work program for next year was discussed and approved by the membership. A report on the review of EWL's membership fees policy was also presented by the membership committee. I hope to present some results of the latter debate in my next message, being a member of this committee.

Even though we are all aware that meeting virtually is not the same as meeting face-to-face, but it is a way we are still connected with each other against all odds. This is something we can build upon when we will meet again in person!

Reports from Regions

A. Central European Region

Dr Edith Schratzberger-Vecsei VP MWIA Central Europe

The COVID 19 situation continues to pose challenges for the region. As mentioned in my earlier June update as physicians we continue to see psychosomatic and psychological challenges in our patient population. The meetings of the national associations in the region continue to be virtual. With the numbers of COVID rising and there is a possibility of lockdown measures being in place again. In September Dr. Schratzberger-Vecsei participated on a conference which focused on the strategies and concepts for effective COVID management.

The Austrian annual meeting planned for October 2020 has been cancelled.

B. Northern Europe

Dr Elizabeth Lichtenstein VP MWIA Northern Europe

Finland

The Finnish Medical Women Association board has hold one meeting and one tele meeting after the Covid-19 outbreak. We plan to arrange a professional event later during the fall and provide a streaming service to better reach our members. The established, close co-operation with the National Council of Women in Finland continues.

The reservation for the next Northern Europe regional meeting is May 7th-9th, 2021 remains valid. We are, however, prepared to adjust the plan in accordance with the actual COVID--19 situation. The final decision about the conference will be made by early 2021 at the latest.

The Covid-19 pandemic has changed the everyday life of all citizens in our country (population. 5,5 million) The first case of the coronavirus in Finland was confirmed on January 29, 2020. By September 10, 2020, the number of confirmed cases in the country has reached a total of 8,512. The death toll is 339 by mid September 2020 and there are presently 14 people hospitalized. In international comparisons our figures are very low, but the amount of cases is steadily growing.

The national safety measures are comprehensive. Wearing a face mask is recommended in public transport, for persons seeking the coronavirus test on their way to take the test and before the completion of test results and when passengers arriving in Finland from a risk area making their way from the place of arrival to quarantine or who they have an urgent reason to spend time outside the home during quarantine.

The "Koronavilkku" mobile app is part of the Finnish government's test, trace, isolate and treat strategy. The free of charge "Koronavilkku" smartphone app has been published to help break infection chains. The app makes it more efficient to reach people exposed to the virus and refer them to treatment. It has been over 2 Million loadings so far. The app will allow people to participate in preventing the spread of the virus and to protect their own and their loved ones' health faster.

Sept.17th, 2020

Tuula Saarela NC, Finland

Netherlands

Of course, this calendar year was completely ruled by Covid-19 in the Netherlands too. By march this year the south became an epic center in which complete hospitals were floated with severely ill patients. In Rotterdam, a national coordinating center was installed which managed the spread of patients in need of an intensive care (IC) treatment. All hospitals had to upgrade IC capacity which asked the high flexibility and development of new skills in a minimum of time. An extraordinary team spirit took hold of all teams both in hospitals but also in nursing home, which were hit extremely hard. This last case was especially the consequence of a lack of personal protecting equipment (PPE). Today, marked September 17th a total of 88.073 patients were tested positive, 82 positive cases/100.000 habitants were reported these last 14 days.

Due to Covid-19 all other regular health care was paused, consequences measured in numbers (with deadly outcome) are not yet clear. Increased stress levels because of the lockdown have resulted domestic violence, women in academics were struggling to uphold their deadlines. Combining both family life and professional life has always been a challenge, however the lockdown made this a terrible struggle.

On the positive side we have seen an increase of 24 to 36% of women board members in Dutch hospitals. The team spirit created within all teams was exceptional and described as the best positive side effect within this devastating pandemic.

On a personal note I have been taking active part in a new movement 'happy in healthcare' last November. The direct cause was alarming number of 20% burn-out among residents. Among residents and young specialist different brainstorm sessions were organized to make an inventory of which priorities were needed to restore a happy and healthy working climate. A successful and very inspiring evening of which the result will be analyzed by prof Dr. Lombarts, professor professional performance. A project to be continued....

As chair of the young MWIA it was a great pleasure to attend the zoom meeting with 58 women (executive committee, vice presidents of the regions). A new era has emerged in which the digital revolution will prevail; our Facebook and Twitter account are actively visited. The twitter account I have started and social media I run reach more and more (young) colleagues every day. I would love to speak to you there, hear what you have learned or would like to learn from the talent MWIA has to offer.

Ireland

While 2020 has been a challenging and unusual year for us all, the Women in Medicine in Ireland Network (WiMIN) has continued to advocate and agitate on behalf of female doctors and medical students in Ireland.

In January, our founder Dr Sarah Fitzgibbon spoke at a well-attended Study Day for local GPs in Cork about physician wellbeing and the importance of self-care, based on her own experiences as a patient and a doctor. In February, she spoke at an event hosted by University College Cork Medical Society, to discuss the issues of gender in medicine.

March 2020 began with a conference organised by the RCSI student chapter of the Association of Women Surgeons, with an inspiring line-up of speakers including the pioneering Professor Averil Mansfield. Dr Fitzgibbon encouraged the students in attendance to avail of the supports of their senior colleagues through mentorship and informal connections.

Our own national conference was due to take place in Belfast on March 21st but was inevitably cancelled as the Covid19 pandemic took hold on our island. While initially rescheduled until September, we have now set our new date for March 13th, 2021. We aim to make the conference fully accessible via web streaming, thereby ensuring accessibility for as many participants as possible. We will miss the face-to-face collegiality, but we will enjoy sharing our experiences, nonetheless.

April was a month filled with webinars, remote meetings, teleconferences, and very steep learning curves, as we all grappled with the changes imposed upon us by the pandemic. In May we had an enjoyable and collaborative video call with Professor Neena Modi of the UK's Medical Women's Federation, looking at areas where our two national organisations could work together.

Throughout the summer months we have collaborated with various national organisations, including participating in a focus group for Action Team 16 of the Our Public Service 2020 reform framework. This aims to improve equality, diversity, and inclusion in the public service in Ireland. We also contributed to research being carried out on behalf of the National Women's Council of Ireland (NWCI) on women's committees/caucuses in local government, and helped in the editing of updated guidelines for healthcare professionals in the area of female genital mutilation (FGM), published by AkiDwA.

Our weekly #SundayWiMIN social media campaign remains extremely popular. Each Sunday a different medical woman with connections to Ireland is honoured with a tribute on Facebook, Instagram, and Twitter. These women include doctors and medical students who have achieved great heights either personally or professionally (and some of them literally, like our Everest mountaineer!)

We hope to host a virtual conference soon, to allow our members to gather informally online, to connect and share, and to strengthen our ties in this most difficult of times.

Sweden



The Swedish Association has during the summer did not have any activities due to holidays and Covid-19 situation where many of us have done numerous hours at the hospitals.

In early September, the board of the Swedish Medical Women's Association had their AGM on Zoom where the new board was elected. This was followed by the constitutional board meeting and two days of planning the for future events within the national Association.

During this weekend three propositions have been written to the Swedish Medical Association suggesting that they work for Equal pay for male and female doctors, that a gender perspective and gender analysis should be included in all reports presented by the Swedish Medical Association, and that the Swedish Medical Association puts pressure on all the medical universities to include gender medicine in their curriculum. As the Swedish Medical Association does not have their AGM until November, we do not know yet if they will incorporate these resolutions.

We are also continuing to work together with the Finnish women's medical Association towards the Northern Europe Regional meeting and the new dates proposed are May 7-9, 2021, thus being that the COVID-19 situation is solved.

After a long day's work with meetings via Zoom and IRL we all relaxed and had a good dinner at the venue where we were staying just out of Stockholm. This is our new executive committee:

United Kingdom

MWF President Professor Neena Modi was elected to be British Medical Association President 2021-2022, at the BMA AGM on September 15^{th.} Our immediate Past President Helena Bowden Jones, an Addictions Specialist, gave the Victor Horsley lecture on gambling at the BMA annual representative meeting. This Meeting had been condensed from 5 days to one on Zoom, due to COVID 19. Dr Helena Mckeown chaired the Annual Representative meeting. The MWF collaboration with the BMA on gender equality was highlighted by Dr Chaand Nagpaul in his opening address.

MWF members have maintained a high profile in the media, holding our Government to account. MWF continues to lobby for fair treatment of NHS staff during the COVID Pandemic with equality embedded in the system. Retired colleagues who felt able to return to the workforce during the pandemic were enabled to do so.

MWF continues to publish a monthly newsletter to our members. A 'Heroes of the NHS 'Annual Junior Doctors Prize, including prose poetry and artistic contributions is being held, and will be judged in due course. Our autumn /winter edition of Medical Woman magazine is about to be published and has a dedicated section to MWIA activity.

MWF is consulting on the current Obesity Strategy.

We are also collaborating with Womanthology Founder, Fiona Tatton on relevant health issues to women. Professor Wendy Savage continues her campaign to preserve every woman's right to choose, in relation to abortion and proposed a motion which was unanimously agreed on this subject at the BMA meeting.

The Keep our NHS Public campaign which she instigated goes from strength to strength, and Richard Horton, editor of the Lancet, gave a hard-hitting critique of our Governments shortcomings in handling the Coronavirus Pandemic.at the AGM on the 12th September.

C. Southern Europe

Report from Italy

Italy is continuing to recover after the Covid-19 emergency. The National Health System is restoring ordinary healthcare activities, but organizing support services in the event of a resumption of the pandemic

The Italian Medical Women's Association (AIDM) with the support of the Ministry of Health, continues to maintain an active toll-free number to answer doubts and requests of Italian women regarding Covid-19.

Furthermore, AIDM, in collaboration with the Higher Institute of Health and the Federation of Italian Scientific Societies, has developed a distance learning course (FAD) entitled "Covid-19 health emergency and gender differences in epidemiology and in the clinic".

Along the whole "Boot", despite the objective difficulties, there are numerous initiatives from the sections

The Rome section has developed a project with an association of psychologists for the stress assessment of general practitioners during the Covid-19 epidemic.

The Bari section has organized a series of webinars, which will take place from September to December, entitled" *AIDM and medical-scientific news* "

A sign of hope comes from the Lombardy Region, the most affected by the pandemic: the sections of Bergamo, Brescia, Crema, Milan and Pavia have organized a regional congress for November 14, in Crema, entitled "Covid-19: The After. New maps of gender medicine between body and mind".

On 29 August, our National President, Dr. Antonella Vezzani, took part in the National Congress of Italian Hospital Cardiologists and participated in a round table entitled: "*HEART OF A WOMAN: HEALTH IN THE FACE OF THE CHALLENGES OF GENDER MEDICINE*"

D. Report from North America

Canada

Federation of Medical Women of Canada

Our Dr. Mamta Gautam, Physician Health, Leadership Guru and Past President, led "Coping with COVID" on May 19th to our membership. She offered weekly check-in virtually for women physicians across Canada since the start of COVID. This service was utilized; themes covered the impact of COVID and how this changed over time for women physicians.

Some of the local branches opened their virtualized events to the general membership, such as the Vancouver branch's book club.

Our AGM will be held October 3rd virtually. This will be followed by our national HPV Prevention Week October 5th to 9th.

From our subcommittees:

1.WPS - Women Peace and Security

A. produced a document on the "Abortion Myths" to be shared on our website and with other national organizations.

2.Gender Based Violence

A. began a fundraising campaign to support women's shelter in specific regions

3.HPV week will start on October 5^{th} now marking the 3^{rd} year in Canada that this is celebrated, with daily webinars and an educational presence on social media.

MWIA and Women's Conferences

The focus on women started long before Beijing with three prior world conferences. Mexico City hosted the first World Conference on Women in 1975 to coincide with International Women's Year and the beginning of the UN Decade for Women. The second was in Copenhagen in 1980 to report on progress from Mexico City and with an emphasis on employment, health, and education. In 1985, Nairobi was host to the third conference, which resulted in the Forward-Looking Strategies for the Advancement of Women. However, the strategies were focused on women and ignored the power relations between women and men.

A turning point for gender equality and the empowerment of women was the International Conference on Population and Development that occurred in Cairo in 1994. MWIA's own Dr. Florence Manguyu headed its NGO section. It was realized that any gains in health and population depended on the involvement of women.

Beijing was the fourth World Conference in 1995, resulting in the Beijing Platform for Action. The key words first heard in Nairobi once again were gender equality and the empowerment of women, but with a commitment to gender mainstreaming to be applied to all UN activities.

Despite reviews every 5 years since 1995 the achievable goals from Beijing have not been achieved, mainly for political and financial reasons. One must ask the question as to whether it is in the best interest of those in power to make women equal and empowered?

There are some highlights of the conference that come to mind. Hillary Clinton led the US delegation and made the famous statement that women's rights are human rights. The NGO's were situated miles from the main meeting, making it difficult to interact with the government delegations. Although many of MWIA's national associations were at Beijing, the official delegation from MWIA consisted of Drs. Dorothy Ward, Carolyn Motzel, Satty Gill Keswani, Vibeke Jorgensen, and Catrin Williams.

The conference was a watershed moment for gender equality and empowerment of women and the desire to attain those two goals has driven us onward. Primary education, maternal mortality, and gender-based violence have all seen some improvement. Money and political will remain the biggest obstacles. Dr. Gro Harlem Brundtland, a former Director General of WHO and former Prime Minister of Norway, said that no country treats its women the same way it treats its men. Going forward, UN Women has created the Generation Equality Forum, which will proceed in 2021, having been delayed due to Covid19.

MWIA took Beijing's commitment to gender mainstreaming to heart and wrote the Manual for Gender Mainstreaming in Health. For health, gender mainstreaming has 3 aspects: the first is that sex and gender medicine focuses on the biologic differences in illness and health between women and men, but secondly the more important aspects are the gender roles and norms and power relations between women and men lead to inequities that influence health. And thirdly, gender mainstreaming and the empowerment of women address inequality and improve health outcomes. The importance of gender mainstreaming has once again come to light in this time of Covid-19, as women's lives have been disproportionately affected compared to men.

September is Women in Medicine Month in the U.S. and AMWA has partnered with She Leads Healthcare and Executive Leadership in Academic Medicine to host the campaign #Her Time Is Now to promote gender equity in medicine. AMWA co-sponsored the 3rd Sex and Gender Health Education Summit which was held virtually and brought together sex and gender health experts, faculty, and students to promote the integration of sex and gender health into educational curricula. The Summit included attendees from all the major health professions, medicine, nursing, pharmacy, dentistry, physical therapy/occupational therapy, EMT, and physician assistant schools. 

1. SPHERE COVID-19 Coalition:

NHMRC Centre of Research Excellence in Sexual and Reproductive Health for Women in Primary Care (SPHERE) which AFMW is a supporter of, has received government funding to commence a five-year project ORIENT, that will test the efficacy and cost-effectiveness of a nurse-led model of care in general practice, to increase long-acting reversible contraception (LARC) uptake and improve access to early medical abortion services in rural and regional areas. The multidisciplinary ORIENT team comprises leading Australian and international researchers, in collaboration with patients and key primary care and rural sexual health stakeholders. . Actively contain the spread of COVID-19	 Coronavirus is raging all over the world, and lives are being lost every day. In the face of this serious crisis, CMWA has responded actively to roll out all the possible channels to be part of the strength to fight against COVID-19°.
	 CMWA members fearlessly joined the National Emergency Rescue Medical Team to take over and to support the medical care in Wuhan, Heilongjiang and Jilin, where were the COVID-19 pandemic areas. CMWA doctors also traveled thousands of miles to Europe and Africa to help local healthcare professionals to provide vital medical care to local patients.
	• CMWA experts took the leadership in conducting COVID-19 related clinical studies, issuing clinical guidelines to improve the understanding of the virus and to promote the clinical experience to benefit the patients, i.e. Prof. Qiao Jie conducted multidisciplinary clinical research focusing on the maternal/new born baby safety. Prof. Zhang Lina, critical care expert from Xiangya Hospital, published national guideline in clinical ultrasonography application of COVID-19 pneumonia.
	CMWA sub-societies and provincial branch associations also called for donations to support with medical equipment and PPE with warm response among members.

Share & exchange updated scientific experience of COVID-19

- CMWA has actively conducted numerous virtual meetings with national/international medical communities, to share updated COVID-19 information and experience.
- Joint effort between CMWA members and other scientific organizations were recognised.
- China Association for Science and Technology, and Chinese Medical Association have jointly put in place a COVID-19 Academic Research Communication Platform for worldwide researchers to release results and participate in discussion. By May 31, a total of 104 journals and 970 papers and reports had been posted.
- Chinese Academy of Sciences has released the 2019 Novel Coronavirus Resource database and built the Novel Coronavirus National Science and Technology Resource Service System and the COVID-19 Pneumonia Scientific Literature Sharing Platform. As of May 31, the three platforms had provided nearly 48 million downloads, browsing and retrieval services to more than 370,000 users worldwide.
- China has established an international pool of experts and has cooperated with other countries in vaccine and medicine research and development. Chinese scientists, medical institutions, and disease control centers have published dozens of well-researched papers in some of the world's leading academic journals such as The Lancet, Science, Nature, The New England Journal of Medicine and etc.
- Medicine research and development, and experimental results of vaccines on animals. To accelerate the development of vaccines and the clinical trials of medicines, China has also carried out cooperation in scientific research with other countries, and with such organizations as the WHO, the Coalition for Epidemic Preparedness and Innovation and the Global Alliance for Vaccines.




